INSURANCE CERTIFICATE REQUIREMENTS:

NEFF RENTAL MUST BE NAMED AS:

1. CERTIFICATE HOLDER
2. ADDITIONAL INSURED IN REGARDS TO A MINIMUM OF \$1 MILLION GENERAL LIABILITY.
3. LOSS PAYEE IN REGARDS TO ADEQUATE RENTED OR INLAND MARINE COVERAGE.
\$200,000 RECOMMENDED AMOUNT OF COVERAGE.
4. AUTO LIABILITY COVERAGE COMBINED SINGLE LIMIT OF MINIMAL \$1 MILLION FOR ANY OR HIRED OR NON AUTO. (FOR AUTO RENTAL ONLY)
WHEN RENTING AN ON ROAD VEHICLE PHYSICAL DAMAGE COVERAGE OF:
A: \$50,000 PICK UP TRUCK RENTAL
B: \$100,000 WATER OR DUMP TRUCK RENTAL
C: \$200,000 ALL CRANE TRUCK RENTAL
D: \$100,000 ALL OTHER AUTOS
5. CANCELLATION NOTICE MUST BE SENT 30 DAYS WRITTEN NOTICE TO CERTIFICATE HOLDER.
6. AUTHORIZED SIGNATURE ON CERTIFICATE
7. NO HANDWRITTEN CERTIFICATES ACCEPTED

PLEASE NOTE:

A VALID CERTIFICATE IS NEEDED AT THE COMMENCEMENT OF THE RENTAL CONTRACT OTHERWISE THE 15% DAMAGE WAIVER FEE WILL BE INCLUDED ON THE CONTRACT. SOME STATES REQUIRE ADDITIONAL ADDENDUM PAGES FOR LOSS PAYEE AND ADDITIONAL INSURED.

ANY DAMAGE WAIVER FEE CHARGED ON THE RENTAL CONTRACT WILL NOT BE CREDITED BACK

THE DAMAGE WAIVER FEE WILL NOT BE CHARGED ON THE RENTAL CONTRACT UPON ACCEPTANCE OF THE VALID INSURANCE CERTIFICATE UNTIL POLICY IS CANCELLED OR EXPIRES.
